CO MONITORING

Effective July 1, 2011 the State of California requires residences to have working carbon-monoxide detectors installed. Senate Bill 183 was signed by Gov. Schwarzenegger last year and aims to prevent deaths from carbon monoxide poisoning. The law currently affects single-family homes and small apartment complexes (four units or less) with fuel burning appliances or an attached garage. Larger complexes and multi -family dwellings will not be affected until 2014.

Fire officials will not be going door-todoor to inspect homes to ensure a CO monitor is installed. However, the state

is enforcing monitors be included in plans for any new building or remodeling permits. Home sales and rental contracts must also include the required monitors. Failure to comply may lead to a \$200 fine; however owners will have thirty days to correct the problem. All new construction must have monitors hard wired into their home.

Advanced Security Systems installs CO Monitors to meet the requirements as well as your needs. It is recommended to install a monitor on every level of your home, as well as in a central location outside each sleeping

area. The monitor will be wired into your alarm system, allowing for us to monitor at our local Central Monitoring Station.

Please remember that carbon monoxide is an invisible gas produced by burning fuels such as, gas, oil, wood, or coal. The symptoms of carbon monoxide poisoning are similar to flu symptoms and include shortness of breath, nausea, dizziness, light-headedness or headaches.
